The affected products represent around 6 percent of Welspun's annual business. The product line in question with Walmart accounts for approximately 1.5% of Welspun's annual business.

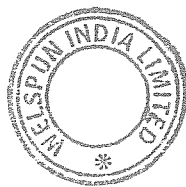
We will continue to support our customers and meet the highest standards of quality for all of the products we manufacture.
